Sealed Bids for the construction of the **Pump Station #7 Replacement** will be received by **Town of Beaufort**, at the office of the **Beaufort Train Depot located at 614 Broad Street, Beaufort, NC 28516**, until **2:00 PM** local time on **Thursday, November, 6, 2025**, at which time the Bids received will be **publicly** opened and read.

The project consists of replacing the existing 150 gpm wet pit/dry pit style pump station with a new 291 gpm submersible sewage pump station. The new pump station will include a new 8-foot diameter precast concrete wet well, check valve vault, meter vault, new electrical and control panels, new telemetry, a new emergency generator, approximately 180 LF of 8-inch RJPVC/PVC forcemain, four (4) new manholes and associated gravity lines to redirect flow to the new wet well.

Bids must be submitted on the complete project. Bids must be enclosed in a sealed envelope, addressed to the **Town of Beaufort, 701 Front Street, P.O. Box 390, Beaufort, NC 28516** and the outside of the envelope must be marked “**Bid for Town of Beaufort – Pump Station #7 Replacement**”. All bids must be made on blank forms provided and included in the bound document. The name, address, and license number with limitation and classification of the Bidder must be plainly marked thereon.

Contractors are notified that North Carolina G.S. 87 relating to licensing of contractors will be observed in receiving bids and awarding contracts.

The Issuing Office for the Bidding Documents is Rivers & Associates, Inc. Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of 8:00 AM – 5:00 PM local time, and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Bidding Documents also may be examined online at **ConstructConnect Plan Room** www.constructconnect.com and at the office of the **Town of Beaufort, 701 Front Street, Beaufort, NC 28516**.

Printed copies of the Bidding Documents may be obtained from the Issuing Office, during the hours indicated above, upon payment of a deposit of **\$150** for each set. Bona fide bidders who return full sets of the Bidding Documents in good condition (suitable for re-use) within 10 days after receipt of Bids will receive a full refund. An additional electronic (.pdf) version of plans and specifications may be purchased for an additional \$35.00 non-refundable fee. Checks for Bidding Documents shall be payable to “Rivers & Associates, Inc.”. Upon request and receipt of the document deposit indicated above, the Issuing Office will transmit the Bidding Documents. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder’s date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

A **non-mandatory** pre-bid conference will be held at **2:00 PM** local time on **Thursday, October, 23, 2025** at the **Beaufort Train Depot located at 614 Broad Street, Beaufort, NC 28516**. Attendance at the pre-bid conference is highly encouraged **but is not mandatory**. In accordance with the Minority Participation Goals, potential prime Contractor(s), should attend the Pre-Bid Conference.
