Sealed Bids for the construction of the **Wastewater Asset Inventory Assessment Sanitary Sewer Evaluation – Phase II – CCTV Contract** will be received by the **Town of Bridgeton, NC at Bridgeton Town Hall, 202 North B Street, Bridgeton, NC 28519 until 2:00 PM** local time on **Tuesday, November 26, 2024**, at which time the Bids received will be **publicly** opened and read. The Project consists of the following work:

Clean & Closed-Circuit Television (CCTV) inspection of approximately 22,300 LF of gravity sewer mains ranging in diameter between 6” to 10” and inspection of approximately 100 sewer manholes.

Bids must be submitted on the complete project. Bids must be enclosed in a sealed envelope, addressed to the **Town of Bridgeton, 202 North B Street, Bridgeton, NC 28519 (FedEx/UPS) or P.O. Box 570, Bridgeton NC 28519 (USPS)** and the outside of the envelope must be marked “**Bid for Town of Bridgeton Wastewater Asset Inventory Assessment – SSES – Phase II – CCTV Contract**”. All bids must be made on blank forms provided and included in the bound document. The name, address, and license number with limitation and classification of the Bidder must be plainly marked thereon.

A non-mandatory pre-bid conference will be held at **2:00 PM** local time on **Thursday, November 14, 2024** at **the office of Rivers and Associates, Inc.** located at **107 E. 2nd Street, Greenville, NC 27858**. Attendance at the pre-bid conference is highly encouraged but is not mandatory. In accordance with the Minority Participation Goals, potential prime Contractor(s), should attend the Pre-Bid Conference. A virtual attendance option is being provided for prospective bidders who are unable to attend in-person. The virtual meeting will be hosted live using Microsoft Teams software. Compatibility of software shall be the responsibility of each prospective bidder. Include the attendee’s first and last name, firm, and contact information in the email. The Engineer shall keep record of all in-person and virtual attendees but it is the responsibility of each prospective bidder to ensure compliance with the Minority Participation Goal requirements.

An additional electronic (.pdf) version of plans and specifications may be purchased for an additional \$35.00 non-refundable fee. Checks for Bidding Documents shall be payable to “Rivers & Associates, Inc.”. Upon request and receipt of the document deposit indicated above, the Issuing Office

will transmit the Bidding Documents. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.
