Sealed Bids for performance of the work for the **Town of Hamilton Sewer AIA Phase II SSES Clean & TV Inspection Contract** will be received by **The Town of Hamilton, NC**, at the office of **Rivers and Associates, Inc. at 107 East 2<sup>nd</sup> Street, Greenville, NC 27858** until **2:00 P.M.** local time on **January 23<sup>rd</sup>, 2025** at which time the Bids received will be **privately** opened and read. The Project consists of:

**Clean and Closed Circuit Television (CCTV) inspection of approximately 13,250 LF of 8” gravity sewer mains and inspection of approximately 64 manholes.**

Bids must be submitted on the complete project.
