WASHINGTON COUNTY
PEA RIDGE WATER TRANSMISSION MAIN
WASHINGTON COUNTY, NORTH CAROLINA

Sealed Bids for the construction of the **Washington County – Pea Ridge Water Transmission Main** will be received by **Washington County**, at the office of the **County Manager** located at **116 Adams Street, Plymouth, NC 27962** until **2:00 PM** local time on **Tuesday, April 22, 2025**, at which time the Bids received will be **publicly** opened and read.

The project consists of the installation of approximately 39,330 LF of 12” water main, 14,685 LF of 6” PVC water main, and a new 550 gpm packaged booster pump station, and all associated tie-ins, valves, and other appurtenances.

Bids must be submitted on the complete project. Bids must be enclosed in a sealed envelope, addressed to **Washington County, P.O. Box 1007, 116 Adams Street, Plymouth, NC 27962** and the outside of the envelope must be marked **“Bid for Washington County Pea Ridge Water Transmission Main”**. All bids must be made on blank forms provided and included in the bound document. The name, address, and license number with limitation and classification of the Bidder must be plainly marked thereon.

Contractors are notified that North Carolina G.S. 87 relating to licensing of contractors will be observed in receiving bids and awarding contracts.

The Issuing Office for the Bidding Documents is Rivers & Associates, Inc. Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of 8:00 AM – 5:00 PM local time, and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Bona fide bidders who return full sets of the Bidding Documents in good condition (suitable for re-use) within 10 days after receipt of Bids will receive a full refund. An additional electronic (.pdf) version of plans and specifications may be purchased for an additional \$35.00 non-refundable fee. Checks for Bidding Documents shall be payable to “Rivers & Associates, Inc.”. Upon request and receipt of the document deposit indicated above, the Issuing Office will transmit the Bidding Documents. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder’s date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.
